**WITNESSETH** that the Contractor and VMI, in consideration of the mutual covenants, promises and agreements herein contained, agree as follows:

**SCOPE OF CONTRACT:** The Contractor shall **provide Altama Model 629001 compatible Men's leather oxford, and Altama Model 629011 compatible Women's leather oxfords pending submission of an approved sample.**

**PERIOD OF PERFORMANCE:** **3 June 2025 – 30 June 2026 with an option to renew for four (4) additional one year periods.**



**TARIFFS**

In addition to the Contractor's proposal as incorporated in this contract, the Contractor further agrees to the below tariff language:

If the Contractor is impacted by unforeseen or modified taxes, duties, tariffs, or similar measures imposed by any U.S. or foreign authority, on the Contractor's offerings, (including materials, equipment, hardware, software, or services, etc.) the Contractor shall provide sufficient evidence to the Institute showing the unit price paid as of the contract award date or Purchase Order issuance date (whichever is earlier), the applicability of the tariff to the specific goods or materials, and proof of payment of the increased tariff or duty. The evidence must allow the Institute to confirm that the tariff caused the price increase without markup. Any misrepresentation regarding additional payments due to tariffs shall be considered fraud under the *Virginia Fraud Against Taxpayers Act* and may subject the Contractor to damages.
