PERIOD OF PERFORMANCE: **15 July 2025 – 30 June 2026, with an option to renew for four (4) additional one year periods.**

ADDENDUM 1 TO CONTRACT V211-25-047-TCU3

Between JWE, Inc. and Virginia Military Institute

This Addendum is made and entered into as of the date of the last signature below by and between JWE, Inc. and the Virginia Military Institute (VMI), collectively referred to as the "Parties."

This Addendum modifies the terms of Contract V211-25-047-TCU3, executed on July 15, 2025, for Tailored Cadet Uniforms and Accessories, as follows:

Liability for Fabric and Trims

In the event VMI elects not to renew any of the four (4) optional one-year renewal periods of the contract, except in cases of termination for cause, VMI agrees to assume financial responsibility for any fabric, trims, or related components that JWE, Inc. procured in good faith to support the Cadet Tailored Uniform program.

This liability applies only to materials that meet the following conditions:

- Garments associated with the materials have received written sample approval from VMI prior to production.
- Materials were purchased prior to notification of non-renewal and were intended for fulfillment of the contract during the current or upcoming renewal period(s).

JWE will provide supporting documentation for all such materials upon request.

This Addendum shall be incorporated into and made part of Contract V211-25-047-TCU3. All other terms and conditions remain unchanged and in full force.
