



The award document will be a contract incorporating by reference all the requirements, terms and conditions of the solicitation and the contractor's proposal as negotiated.

- E. **CANCELLATION OF CONTRACT:** The purchasing agency reserves the right to cancel and terminate any resulting contract, in part or in whole, without penalty, upon 60 days written notice to the contractor. In the event the initial contract period is for more than 12 months, the resulting contract may be terminated by either party, without penalty, after the initial 12 months of the contract period upon 60 days written notice to the other party. Any contract cancellation notice shall not relieve the contractor of the obligation to deliver and/or perform on all outstanding orders issued prior to the effective date of cancellation.
- F. **FUTURE GOODS:** VMI reserves the right, subject to mutual agreement, for the Contractor to provide additional goods and/or services under the same pricing, terms, and conditions and to make modifications or enhancements to the existing goods and services. Such additional goods and services may include other products, components, accessories, sub-systems, or related services that are newly introduced during the term of this agreement. Such additional goods and services will be provided to VMI at favored nations pricing, terms and conditions.

B2. PLAN AND METHODOLOGY

THE STOCK ORDER PROCESS:

This consists of the customer sending orders by email, fax or phone to our Customer Service team. Elbeco has their own custom ordering form that can be utilized or the customer may use their own form and submit via email or fax. Elbeco's form is not mandatory but simply an option. Once the order is received and updated in our system, the customer will receive an order confirmation (the customer needs to supply an email address to customer service). Once the initial order process is complete, a pick slip is generated for all available inventory. It is then printed by our warehouse manager. Once printed, the pick slip is picked, packed, and ready for delivery. Our warehouse will ship the order within 24-72 hours.

THE SPECIAL ORDER PROCESS:

The special order process is different from our stock program insofar as it is a custom order as opposed to "an off the shelf stock" item. VMI has always been a "special" or custom program for Elbeco. Following confirmation of the proper uniform specification, the customer typically places their orders with the sales rep (administrator)/Customer Service. Fabric is then ordered and production begins once fabric is delivered to the factory. The time frame from orders placed to production completion is usually 90-120 days. In the case of VMI, we (Elbeco) have always "drop shipped" our orders directly from the factory to VMI.

B3. WRITTEN NARRATIVE

Elbeco is a 111 year old manufacturing firm of public safety garments. We are considered one of the very best uniform manufacturers in the Public Safety Industry with annual sales totaling nearly 50M dollars. We have approximately 208 employees with a sales team of nearly 20 corporate and outside sales team members. We are familiar with direct sales to academies having had military academy customers such as The Citadel, Missouri Military Academy, St. Thomas Academy, Fork Union, and VMI. For purposes of this contract, the below listed individuals will be assigned to your account.

- David Rosenblum is the administrator of the contract. David is a thirty (30) year rep of our company and has a wealth of knowledge and experience in both our stock and special programs. David has been on both the retail and manufacturing sides to our industry which gives him an excellent perspective on our industry's processes. David will be your main contact.
- Sandy Ludwig is our Customer Service Manager. Sandy has held a variety of positions at Elbeco starting from Customer Service rep to Credit Manager and now oversees all of Elbeco's Customer Service process. Sandy has been with the company for 18 years.
- Samantha Ludwig is our Contract Coordinator. Sam started as our receptionist and has been in her present position for the last three (3) years. She is responsible for the proper execution of all of our contracts and handles all of our bid operations. Samantha has been with the company for 5 years.
- Tom Wenner is our Warehouse Manager. Tom supervises our entire warehouse team and is primarily responsible for ensuring we pick your right products and have accuracy for all of your deliveries. Tom has been with the company for 13 years.



- TJ Virk is our Vice President of Sourcing and Product Development. He is proficient in the principle applications of sourcing, supply chain management, product development and manufacturing of domestic and global apparel and uniforms. TJ is primarily responsible for managing manufacturing and product Development operations. TJ has been with the company for 12 years.

 - Fully staffed Sewing room which provides after production custom options such as emblem attachments, hemming, and other similar embellishments.

- Style:** Dress-style shirt has a plain reverse front, full cut tapered fit, open sport collar, long sleeves and full dress shirttail with a continuous hem (folded with turnunder, not just serged). Shirt has two plain breast pockets with top-stitched mitered flaps, shoulder board sleeves that accommodate VMI cadet boards and a double-yoke with matching inside yoke of Dacron/cotton poplin. All stitches must be of proper tension to avoid puckering after laundering and/or dry cleaning. All fabric is of first quality, pre-shrunk and color fast. Work wear industrial style shirt construction is unacceptable and is cause for rejection.
- Fabric:** Milliken 2810, 65% polyester/35% cotton with or without M-Stretch Stainmart, weighing 5 oz. per square yard. Color: white herringbone.
- Collar:** One-piece convertible collar measures 3" long with ultrasonically fused-in mylar stays that measure 2 $\frac{3}{4}$ " long x $\frac{3}{8}$ " wide. Collar has a woven fusible interlining, is top-stitched $\frac{1}{4}$ " off the edge and has no neck button or buttonhole.
- Front:** To be made with a Sport shirt front with each front having turnback facings approximately 3" wide. Shirt has six buttons and six buttonholes, spaced 3 $\frac{1}{2}$ " apart. Fronts are joined to the yoke so that both raw edges of the yoke are turned under, with the front sandwiched between, and then all three are stitched down with a $\frac{1}{16}$ " raised stitch. Safety stitch joining is unacceptable.
- Yoke:** Double life yoke for support of lock in shoulder boards corner are constructed to accommodate VMI Boards.
- Pockets:** Two plain patch pockets with mitered corners that measure 5" wide x 5 $\frac{5}{8}$ " deep are set to the shirt with $\frac{1}{16}$ " stitches. Buttons are centered on the pockets to align with the buttonholes in the flaps.
- Flaps:** Two mitered flaps that measure 5 $\frac{1}{4}$ " wide, 2 $\frac{3}{8}$ " deep at center and 1 $\frac{3}{4}$ " long are secured to the shirt $\frac{3}{8}$ " above the pockets with $\frac{1}{4}$ " top-stitches. Buttonholes are centered on the flaps to align with buttons on the pockets.
- Sleeves:** Half sleeves have a 1" wide hem with $\frac{1}{4}$ " turnunder to prevent raveling, and is one piece as specified. Sleeves are straight and whole, have 1" hems, finish 6 $\frac{1}{2}$ " long from each underarm seam to bottom of sleeve for a large (16 $\frac{1}{2}$), and graded accordingly.
- Construction:** Collar and pocket flaps are made with conventional construction. Top ply, bottom ply and interlining are first stitched together, then turned right side out and finally top-stitched.
- Labels:** Each shirt has a permanent care and manufacturer label sewn-in on the inside left tail of the shirt. Neck size is listed on an embroidered label inside the collar.
- Buttons:** All buttons are first grade 19 ligne pearlescent. Replacement buttons are not to be sewn on shirttail. Upon ordering, replacement buttons are supplied in bulk, two buttons per shirt on order.

Sewing: Collar and pocket flaps are top-stitched ¼" off the edge. Sleeve inserting and side close felling seams are safety-stitched.

Thread: All sewing is with color fast polyester wrap thread to match fabric and has no monofilament.

Interlining: Collar has fusible interlining. Pocket flaps are interlined with EZ Crease.

Military Creases:

Shirt has five sharp permanent military creases. One crease in each front is centered vertically through pockets and flaps. Three vertical creases are in back; middle crease is on the center line and side creases are spaced equally from the center crease.

Stock Sizes: Shirts must be available in sizes Small through 4XL. Package three shirts per box shipped.

- Style:** Dress-style shirt has a plain reverse front, full cut tapered fit, open sport collar, long sleeves and full dress shirttail with a continuous hem (folded with turnunder, not just serged). Shirt has two plain breast pockets with top-stitched mitered flaps, shoulder board sleeves that accommodate VMI cadet boards and a double-yoke with matching inside yoke of Dacron/cotton poplin. All stitches must be of proper tension to avoid puckering after laundering and/or dry cleaning. All fabric is of first quality, pre-shrunk and color fast. Work wear industrial style shirt construction is unacceptable and is cause for rejection.
- Fabric:** Milliken 2810, 65% polyester/35% cotton with or without M-Stretch StainSmart, weighing 5 oz. per square yard. Color: white herringbone.
- Collar:** One-piece convertible collar measures 2 $\frac{7}{8}$ " long with ultrasonically fused-in mylar stays that measure 2 $\frac{1}{2}$ " long x $\frac{3}{8}$ " wide. Collar has a woven fusible interlining, is top-stitched $\frac{1}{4}$ " off the edge and has no neck button or buttonhole.
- Front:** To be made with a Sport shirt front with each front having turnback facings approximately 3" wide. Shirt has five buttons and five buttonholes, spaced 3 $\frac{1}{2}$ " apart. Fronts are joined to the yoke so that both raw edges of the yoke are turned under, with the front sandwiched between, and then all three are stitched down with a $\frac{1}{16}$ " raised stitch. Safety stitch joining is unacceptable.
- Yoke:** Double life yoke for support of lock in shoulder boards corner are constructed to accommodate VMI Boards.
- Pockets:** Two plain patch pockets with mitered corners that measure 5" wide x 5 $\frac{5}{8}$ " deep are set to the shirt with $\frac{1}{16}$ " stitches. Buttons are centered on the pockets to align with the buttonholes in the flaps.
- Flaps:** Two mitered flaps that measure 5 $\frac{1}{4}$ " wide, 2 $\frac{3}{8}$ " deep at center and 1 $\frac{3}{4}$ " long are secured to the shirt $\frac{3}{8}$ " above the pockets with $\frac{1}{4}$ " top-stitches. Buttonholes are centered on the flaps to align with buttons on the pockets.
- Sleeves:** Half sleeves have a 1" wide hem with $\frac{1}{4}$ " turnunder to prevent raveling, and is one piece as specified. Sleeves are straight and whole, have 1" hems, finish 5 $\frac{1}{4}$ " long from each underarm seam to bottom of sleeve for a size 36, and graded accordingly.
- Construction:** Collar and pocket flaps are made with conventional construction. Top ply, bottom ply and interlining are first stitched together, then turned right side out and finally top-stitched.
- Labels:** Each shirt has a permanent care and manufacturer label sewn-in on the inside left tail of the shirt. Neck size is listed on an embroidered label inside the collar.
- Buttons:** All buttons are first grade 19 ligne pearlescent. Replacement buttons are not to be sewn on shirttail. Upon ordering, replacement buttons are supplied in bulk, two buttons per shirt on order.

Sewing: Collar and pocket flaps are top-stitched ¼" off the edge. Sleeve inserting and side close felling seams are safety-stitched.

Interlining: Collar has fusible interlining. Pocket flaps are interlined with EZ Crease.

Military Creases:

Shirt has five sharp permanent military creases. One crease in each front is centered vertically through pockets and flaps. Three vertical creases are in back; middle crease is on the center line and side creases are spaced equally from the center crease.

Stock Sizes: Shirts must be available in bust sizes 28 through 52. Package three shirts per box shipped.

VMI Cadet Male Black Long Sleeve Shirt
Elbeco Style 7112

- Style:** Form fitting shirt has full tail with continuous hem (folded with turnunder, not just surged) and double yoke. All stitches must be of proper tension to avoid puckering after laundering and/or dry cleaning. All fabric must be of first quality, pre-shrunk and color fast.
- Fabric:** Metcalf 9270, 65% Dacron polyester/35% rayon, $\pm 5\%$, tropical weave. Color: VMI black.
- Collar:** Dress style collar is die cut. Back of stand measures $1\frac{3}{8}"$ ($\pm \frac{1}{8}"$). Collar points, medium spread, are 3" long. Interlining is first line commercial quality and stitched. Permanent collar stays of first quality vinyl that measure $2\frac{3}{4}"$ long x $\frac{3}{8}"$ wide are sewn into collar so that no stitches are made through bottom leaf. There is a tie space of $\frac{3}{4}"$ when collar is buttoned.
- Front:** Plain front has a facing approximately $1\frac{5}{8}"$ wide and extends from neckline to bottom of shirt provided by a turnunder of material. Left front has seven buttonholes, $\frac{3}{4}"$ from the edge, 3" to $3\frac{3}{4}"$ apart. Right front has a similar turnunder facing.
- Yoke:** Shirt has a lining in yoke and collar band made of cotton blend, color to match shirt. No manufacturing tags in this area.
- Pockets:** Two plain mitered breast pockets that measure $5\frac{1}{2}"$ wide x 6" deep are located proportional to the size of the shirt.
- Flaps:** Two mitered flaps that finish along the width of pocket, $2\frac{3}{8}"$ deep at center, are stitched in front of shirt $\frac{1}{4}"$ above top pockets. Buttons on center of pockets align with buttonholes in center of flaps.
- Sleeves:** To be straight and whole with sleeve vents from the top of cuffs. Sleeves have vents with top facing of $1\frac{1}{8}"$ wide finished at top with neat block points. Each sleeve has an approximate 5" sleeve vent and fastens with a two-button adjustable cuff.
- Cuffs:** Barrel-type cuffs measure a finished minimum of $2\frac{3}{4}"$ wide, top-stitched $\frac{1}{4}"$ around edge of cuffs with rounded corners. Cuffs fasten with two buttons and one buttonhole to allow cuffs to be adjustable. The two buttons are evenly spaced to prevent puckering when fastened. Cuffs are die cut for uniform fit and are attached to sleeves by double-stitching $\frac{1}{4}"$ apart, visible on outside of cuffs.
- Construction:** Collar and pocket flaps are made with conventional construction. Top ply, bottom ply and interlining are first stitched together, then turned right side out and finally top-stitched.

- Style:** Form fitting shirt has full tail with continuous hem (folded with turnunder, not just surged) and double yoke. All stitches must be of proper tension to avoid puckering after laundering and/or dry cleaning. All fabric must be of first quality, pre-shrunk and color fast.
- Fabric:** Metcalf 9270, 65% Dacron polyester/35% rayon, $\pm 5\%$, tropical weave. Color: VMI black.
- Collar:** Dress style collar is die cut. Back of stand measures $1\frac{3}{8}"$ ($\pm \frac{1}{8}"$). Collar points, medium spread, are 3" long. Interlining is first line commercial quality and stitched. Permanent collar stays of first quality vinyl that measure $2\frac{3}{4}"$ long x $\frac{3}{8}"$ wide are sewn into collar so that no stitches are made through bottom leaf. There is a tie space of $\frac{3}{4}"$ when collar is buttoned.
