**COMMONWEALTH OF VIRGINIA
STANDARD CONTRACT**

Contract Number **V211-22-072**

This contract entered into this **28th day of March 2022** between **UNX industries, Inc.**, TIN **83-4505552**, hereinafter known as the "Contractor" and the Commonwealth of Virginia, **Virginia Military Institute**, hereinafter known as the "Purchasing Agency".

WITNESSETH that the Contractor and the Purchasing Agency, in consideration of the mutual covenants, promises and agreements herein contained, agree as follows:

SCOPE OF CONTRACT: The Contractor shall provide Laundry Chemicals and Dispensing Equipment services to Virginia Military Institute as set forth in the contract documents. Chemical and Dispensing Equipment will be fully implemented and ready for use within thirty (30) days of the executed contract.

PERIOD OF PERFORMANCE: Start Date: **28 March 2022** through **30 June 2023** with three (3) one-year renewal options remaining.

COMPENSATION AND METHOD OF PAYMENT: The Contractor shall be paid by the Purchasing Agency in accordance with the Contract Documents.

ADDITIONAL NEGOTIATED TERMS: Contractor agrees to the following:

1. Deliveries will be coordinated with other users across Post, specifically the Athletic Department, in an effort to reduce delivery redundancy;
2. Contractor agrees to seek SWaM Certification in their corporate HQ location (North Carolina) and, if qualified, seek SWaM Certification in Virginia.

CONTRACT DOCUMENTS: The contract documents shall consist of:

- (2) Virginia Military Institute's Request of Proposal V211-22-072 in its entirety;
- (3) Contractor's Signed Proposal dated 7 March 2022 including any subsequent submissions received from the Contractor through 8 March 2022;
- (4) The Commonwealth of Virginia's executed Standard Contract Addendum;
- (5) The Commonwealth of Virginia General Terms and Conditions.
